Per SCCA ruling, specific cars will be in Concours as display only and will not be eligible for SCCA judging and awards but will be eligible for special awards or Best of Class Award. All 2009 Class Winners will not be eligible for SCCA judging but may be chosen for a Specialty Award. **ALL VEHICLES MUST CARRY A FIRE EXTINGUISHER.**
